





MEMORANDUM OF ASSOCIATION
OF
HARAGOPAL EDUCATIONAL SOCIETY

1. **NAME OF THE ASSOCIATION:** The name of the Association is Haragopal Educational Society which shall hereinafter be referred to as "Association"
2. **LOCATION OF THE OFFICE:** The registered office of the Association shall be situated at "Swarnadhamma Nagar, Opposite Dairy Farm, Old Bowenpally, Secunderabad - 500 011."
3. **MEMBERSHIP:** Any person, firm, company can become the members of the association by paying the requisite membership fee.
4. **MANAGEMENT:** The management of the Association shall rest in the executive committee of the Association consisting of a President, Vice-President, Secretary, and Treasurer and two committee members.

The general body shall elect all members of the committee.

The Members of the First executive committee shall be as follows

The first executive committee and its members including office bearers shall remain in office up to the conclusion of the first Annual General Meeting, and they are eligible for re-election.

5. **TERM OF OFFICE OF THE COMMITTEE AND MEETINGS:** The Members of the committee shall hold office for a period of two years from the time of assumption of office. Any elected member of the committee may at any time resign from his office by sending a letter of resignation to the President of the Association. But such resignation shall take effect only from the date on which it is accepted by the executive committee.

ii. Meeting of the executive committee shall be convened by the Secretary once in three months or often if necessary for conducting the business of the association. In special circumstances the President may however convene a meeting of the executive committee. The President shall call for a meeting of the committee a month after the receipt of requisition in writing signed by at least 2/3 of the members of the committee for the meeting of executive committee. The quorum shall be 1/4 th of the strength of the committee members. All questions before the committee shall be decided by majority votes.

iii. Should there be an equality of votes, the president or other presiding member shall have a casting vote. No member of the committee shall be present at a meeting when any matter in which he is personally interested is being discussed.

6. ADMINISTRATION:

The entire administration of the association shall vest in the executive committee. Among the powers of the committee shall be:-

- i. To authorise the president to open a bank account with any scheduled or nationalised bank which shall be operated by the President and Vice President as second signatory or in his absence by Secretary.
- ii. To scrutinize and put-up the annual budget to the General Body.
- iii. To prescribe or regulate from time to time the strength of office and establishment and their salaries and allowances and to regulate their works.
- iv. To submit to the General Body the Annual Report and the statement of account.
- v. To make the arrangements for the efficient supervision of the employees association.
- vi. To appoint, suspend, remove or dismiss or otherwise deal with the employees of the association in accordance with service rules and code of conduct.
- vii. To arrange, to maintain such accounts and registers.
- viii. To institute, conduct, defend, compound, compromise or abandon legal proceedings by or against the association.
- ix. To transact all other business incidental to the administration of the association.
- x. To fix the amount and nature of security, if any, to be given by the office establishment.



GENERAL MEETINGS:

- GENERAL MEETINGS.**

 - i. The meeting of the General Body be convened at least once a year or often, if necessary, by the President
 - ii. At every alternative Annual General Body Meeting the members shall elect the executive committee
 - iii. The budget for ensuing year shall be passed and annual report for the previous year shall be approved at Annual General Body Meeting.
 - iv. The annual general body meeting shall appoint auditors each year for audit of accounts of the association
 - v. The annual general body shall be convened after giving 15 days clear notice of proposed meeting to be held.
 - vi. The quorum for the general body meeting shall be one half of the total strength of the members
 - vii. A general body meeting shall be called on the written requisition of atleast five members within a month after the receipt of the requisition by the president
 - viii. The president can call an extra ordinary general body meeting and the association shall maintain the minutes of the meetings
 - ix. There shall be an agenda communicated for every meeting and the association shall maintain the minutes of the meetings
 - x. If there is no quorum the chairman may adjourn the meeting for half an hour and conduct the meeting with any number of members that are present. Such adjourned meeting can deal with any item of the agenda excepting the amendment of bylaws
 - xi. The President or in his absence the Vice-president shall preside over all meetings of the General Body and the executive committee. They shall be allowed to exercise casting vote as second vote whenever there is equality of votes in any issue and in the absence of the president and the vice-president, chairman shall be elected from among those present. The chairman so elected shall also exercise casting vote, as second vote whenever there is equality of votes. No executive committee member including president or vice-president shall be present at a meeting when a matter in which he/she

8. **DISQUALIFICATION OF THE MEMBERS OF THE COMMITTEE:** No person shall be eligible for being chosen as and a member of the committee, if he/she is a default to the association for a period of three months or more in respect of the membership fees or any other amount that is payable to the association.

9. **SERVICES OF THE MEMBER TO BE GRATUITIOUS:** The service of the members of the committee shall be gratuitous.

10. **POWERS OF OFFICE BEARER'S:** Subject to such resolutions as the committee may, from time to time, pass in this behalf, the several officers of the committee shall have the powers mentioned below.

President:

- The president shall exercise general control and supervision over the affairs of the association and the work of its officers. He shall with approval of the committee make arrangements for the safe custody of cash and other properties of the association and frame suitable bylaws for this purpose. He shall be also have power to appoint the members of the establishment as well as remove them and preside over the general body, the committee and other sub-committee
- The president shall exercise the powers delegated to him by the committee, and may subject to the approval of the committee delegate any of its power and duties to the vice-president or in his absence to any committee members for a specified period and may withdraw any power so delegated

Vice President: Whenever the president is obliged to absent from headquarters or ill or any other cause, the vice-president shall exercise the powers and perform the duties of the president.

Secretary:

- The Secretary shall be responsible for the general administration of the association subject to the control of the president
- The secretary shall:
 - Have custody of all account books and the registers of the association.
 - Be an officer to sue or be sued on behalf of the association all the bonds in favour of the association shall be in the name of his office

15. **AMENDMENTS:** No amendments or alteration shall be made in the memorandum or rules of association unless it is voted 2/3rd members present at the special general body meeting convened for the purpose and confirmed by 2/3rd of the members present in a special meeting.
16. **WINDING UP:** In case the association has to be wound up, the property and funds of the association shall be transferred or paid to some other institutions with similar aims and objects.





- c. Have power and on behalf of the association to operate Association's accounts jointly with vice-president or any other authorized person for the purpose and subject to such directions and limits as may be laid down by the committee to buy, sell, pledge endorse and transfer promissory notes, government and other securities standing in the name or held by the association to sign endorse and to sign all receipts and other documents connected with the business of the association.
- d. Have also power to subject to the directions of the committee to accept deposits and to carry on general transaction within the framework of these bylaws.
- e. Arrange for holding of the meetings of the committee and general body.
- f. Attend every meeting of the committee.
- g. To do all that is necessary for carrying on generally the day-to-day administration of the association.
- h. Incur expenditure on contingencies within the budget allotment and within the limits prescribed by the association in respect of each of item.
- iii. Whenever the secretary obliged to absent himself from his office by reason of his absence from head quarters or any other cause the president shall exercise the powers and perform the duties of the secretary.

General Body: The ultimate authority in all matters relating to the administration of the society shall vest in the general body. The general body, shall not however, interfere with the power of the committee in respect of matters delegated to it in the bylaws, the general body shall deal with the following among other matters.
